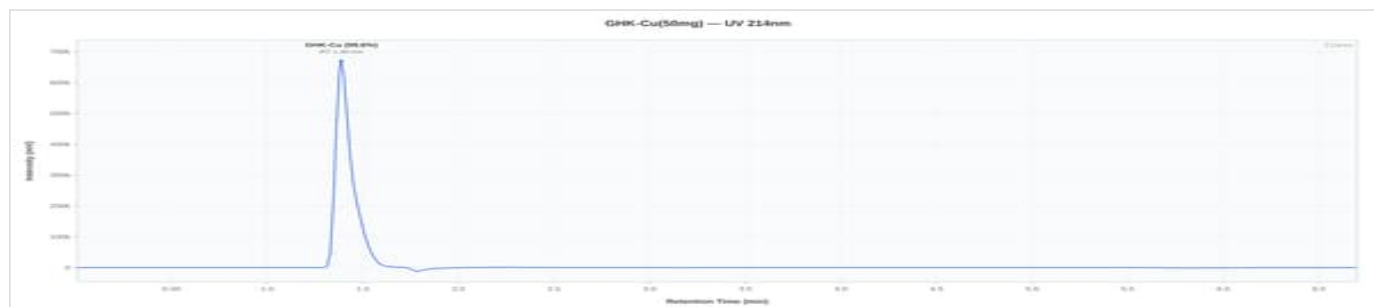

- 1. Date Tested: 08/17/2026. Methods: Purity, Identity & Quantitation (HPLC).
- 2. The sample was confirmed to be GHK-Cu by HPLC. Identification by chromatographic retention time comparison with a reference standard.
- 3. Endotoxin tested per USP <85> kinetic chromogenic method. Acceptance criteria per client specification.
- 4. Peptide purity determined by RP-HPLC area normalization at 214 nm. Value represents the percentage of the target peptide relative to all peptide-related peaks. Non-peptide process-related impurities, if detected, are excluded from the calculation.
